Sorrento is a unique wetting, deposition and penetration aid designed to improve the retention and uptake of plant protection products and to reduce variability of performance under adverse conditions on a wide range of crops.

Sorrento may be used with **all approved plant protection products** applied at their **full rate** up to and including the following crop growth stages:

| Crop                      | To be applied at or before the following crop growth stages:               |
|---------------------------|--|
| Oilseed rape              | up to and including 10% potential pods (code 5.1, Sylvester-Bradley, 1985) |
| Sugar beet                | up to and including 6 fully expanded leaves (EPPO code 23)                 |
| Cereals                   | up to and including GS52(1/4 inflorescence)                                |
| Potato                    | up to and including tuber initiation                                       |
| Forage Maize              | up to and including tip of tassel (code 205)                               |
| Combining and Vining Peas | up to and including 10% full seed (EPPO code 205) (edible only)            |
| Edible podded peas        | up to and including 10% full seed (code 204)                               |

- for use with approved herbicides, post-harvest, on stubble and non-crop areas, and for pasture renovation;
- for use with all approved plant protection products applied at half the approved rate in all crops and non-crop situations.

Sorrento can also be used at full rate up to specific growth-stages in a number of other crops, please speak to Nichino Europe Co., Ltd or its agents for specific **recommendations**.

**RATES OF USE**

Sorrento should be used at a maximum of 1% dilution of the final spray volume.  
For example:

| Water Volume | Required Quantity of Sorrento at 0.1% |
|--------------|---------------------------------------|
| 100 Litres   | 100ml                                 |
| 200 Litres   | 200ml                                 |

**MIXING**

Fill the spray tank three quarters full with clean water and commence agitation. Add the recommended quantity of Sorrento. Then add the recommended quantity of pesticide and the remaining balance of water to the spray tank whilst maintaining agitation throughout.

If foaming occurs, add the required quantity of *Abate* to remove foam.
